Creation of fourteen (14) signs board. <b>In progress.</b></li> <li>● Dec 2022 – Authorisation of road closure has been provided under delegation, including details around advertising this. <b>Completed.</b></li> <li>● Dec 2022 – Procurement process for the metal gates. <b>In progress.</b></li> <li>● Jan 2023 – Traffic works to install seven (7) double sided signs. <b>In progress.</b></li> <li>● Feb 2023 - City Maintenance to install concrete blocks at 6 locations to mitigate vehicle movements. <b>In progress.</b></li> <li>● March 2023 - Installation of metal gates and CCTV cameras infrastructure at 3 locations. <b>In progress.</b></li> </ul> <p><b>Police Patrols update:</b></p> <p>Holcim have continued staggering our Police Patrols and working with Hanson to extend the time period of the patrols.</p> <p>Michelle and Karina met with Hanson and the Pimpama Police officers, as they are the station in charge of the district area, and will be taking over the patrols from Eagleby.</p>
