### **Business Operations**

#### **1. Progress at the mine**

Production has continued within the approved extraction limits, with no operational issues to report. Covid-19 restrictions across New South Wales and Queensland have not adversely impacted

on sales from the site, with the site currently experiencing increased sales to South East Queensland and the Ballina/Byron council. A new dredge (Holcim owned from a QLD site) has arrived on site and will be operational in the coming days. Road rectification works on the entrance road to the quarry will commence Wednesday 14th July. New Quarry Manager and CCC member Matt Kelly.

DPIE undertook a visit to the site on 19th May and no issues were found. An independent environmental audit will be conducted in July by a third party contractor approved by the EPA.
