Acute toxicity	Based on available data, the classification criteria are not met.
Skin	Contact may result in mechanical irritation, redness, rash and dermatitis.
Eye	Contact may result in mechanical irritation, lacrimation and redness.
Sensitisation	Not classified as causing skin or respiratory sensitisation.
Mutagenicity	Insufficient data available to classify as a mutagen.
Carcinogenicity	Not classified as a carcinogen. Crystalline silica is classified as carcinogenic to humans (IARC Group 1). However, adverse health effects are not anticipated given the non respirable nature of the silica quartz in this product (as supplied).
Reproductive	Insufficient data available to classify as a reproductive toxin.
STOT - single exposure	Not classified as causing organ damage from single exposure. However, over exposure may result in irritation of the nose and throat, with coughing.
STOT - repeated exposure	Not classified as causing organ damage from repeated exposure. Adverse health effects, usually associated with long term exposure to high crystalline silica dust levels are not anticipated due to the product form. This product may only present a hazard if respirable quartz dust is generated. Chronic exposure to dust may cause lung fibrosis (silicosis).

## **16. OTHER INFORMATION**

Additional information SILICA - MEDICAL CONSIDERATIONS: Medical testing for those with frequent or potentially high exposure to silica (half the Exposure Standard or more) is recommended before beginning work and at regular intervals thereafter. This should include; Lung function tests - chest x-rays every 1-3 years. If abnormal chest x-ray develops, skin test for tuberculosis should be done. Any evaluation should include a careful history of past and present symptoms with an exam. Medical tests that look for damage already done are not a substitute for controlling exposure.

EXPOSURE STANDARDS - TIME WEIGHTED AVERAGES: Exposure standards are established on the premise of an 8 hour work period of normal intensity, under normal climatic conditions and where a 16 hour break between shifts exists to enable the body to eliminate absorbed contaminants. In the following circumstances, exposure standards must be reduced: Strenuous work conditions; hot, humid climates; high altitude conditions; extended shifts (which increase the exposure period and shorten the period of recuperation).
