**11.1 Information on toxicological effects**

<b>Acute toxicity</b>	Based on available data, the classification criteria are not met. Ingestion of large quantities may result in nausea, vomiting, abdominal pain and diarrhoea.
<b>Skin</b>	Contact may result in mechanical irritation, redness, rash and dermatitis.
<b>Eye</b>	Contact may result in mechanical irritation, lacrimation and redness.
<b>Sensitisation</b>	Not classified as causing skin or respiratory sensitisation.
<b>Mutagenicity</b>	Not classified as a mutagen.
<b>Carcinogenicity</b>	Dust created when the product is cut, grinded and machined may contain crystalline silica some of which may be respirable (particles small enough to go into deep parts of the lung when breathed in). Crystalline silica is classified as carcinogenic to humans (IARC Group 1). However, there is sufficient information to conclude that the relative risk of lung cancer is increased in persons with silicosis. Therefore, preventing the onset of silicosis will also reduce the cancer risk.
<b>Reproductive</b>	Not classified as a reproductive toxin.
<b>STOT - single exposure</b>	Over exposure may result in irritation of the nose and throat, with coughing.
<b>STOT - repeated exposure</b>	Dust created when the product is cut, grinded and machined may contain respirable crystalline silica (particles small enough to go into deep parts of the lung when breathed in). Repeated overexposure to crystalline silica for extended periods may result in silicosis.
<b>Aspiration</b>	This product does not present an aspiration hazard.
